SUBJECT: Board of Directors Meeting – June 29, 2022

The Central New York Regional Planning and Development Board will hold its next meeting on June 29, 2022. The meeting will feature a guest presentation from Joseph Starks, President and CEO of ECC Technologies, LLC.

The CNY RPDB engaged ECC Technologies in November 2020 to prepare a regional broadband internet access study for the region, which was completed and released on December 31, 2021. Mr. Starks will present a summary of the report's findings and recommendations during this meeting. Complementing these remarks will be information provided by Mr. Starks regarding new federal funding initiatives to support improved broadband internet service across the country. Information will also be presented regarding plans the agency is considering to submit an application to the National Telecommunication and Information Administration (NTIA) for a major grant to support the build out of a new fiberoptic Open Access Model – Middle Mile network in Central New York.
